# SCHOOL DISTRICT NO. 83 TRANSPORTATION REVIEW



The Board of Education of School District No. 83 provides bus service to eligible riders as its main priority. At times, bus service may be provided to courtesy riders if it does not have a negative impact on service for eligible riders. The purpose of this report is to outline the courtesy rider issues we currently face and provide recommendations to ensure that we are providing the best services possible to eligible riders in the district.

## **Background and Context**

The Transportation Department in School District No. 83 provides daily school bus service for approximately 3,000 students. The district has 46 buses serving 34 routes, along with transportation for field trips and special events.

The school district covers a large geographical area, making it challenging to provide transportation services to meet all students' needs. District buses travel approximately 6,300 km each day.

District decisions around transportation for courtesy riders have not been consistent in all areas of the district over the years. Additionally, it has been difficult to track riders - especially courtesy riders - within city limits, where students are riding short distances and loads are large. Current accommodations for courtesy riders have outgrown the legal capacity of buses on some routes, leading to some courtesy riders being denied access to bus service.

The district needs to decide on consistent practices around courtesy riders and the Transportation Department needs to be able to make and uphold the decisions to ensure that transportation services are fair and equitable for all riders across the district.

Current courtesy rider issues include:

- Route extensions and additional stops to accommodate courtesy riders
- Transportation to before and after school care
- Transportation to non-educational programs/rides into town
- Courtesy rides for Grade 8 students to attend out of catchment middle school
- Forced cross-boundary students

Communication of district policies and regulations regarding transportation has not been consistent, and access to these documents is currently difficult for students and parents; at times creating expectations that are not within the scope of the current regulation.

## **Analysis**

A revised "Bus Transportation" Regulation (5040.02R) is included to provide clarity around eligible and non-eligible riders (Page 3).

An analysis of specific routes is also included in this review and identifies issues with courtesy ridership and recommends adjustments to routes to improve services for eligible riders in the district (Pages 4-29).

## Regulation 5040.02R - Bus Transportation

It is the parents' responsibility to determine how their children will travel safely to and from school, or to and from the bus pick up and drop off locations. Bus transportation provided by the district is one option.

In accordance with the *School Act*, bus transportation for students to use in going to and from school is provided at the discretion of the Board. It is recognized that bus transportation routes will not suit the requests of all parents.

#### **Eligible Riders**

To be eligible for consideration for regular bus transportation to and from school, the student must:

- Attend their catchment area school;
- Live more than 3.5 km from his/her catchment area school.

The calculation of distance for determining eligibility for transportation services is based on distances measured from a student's home where a driveway connects to a public road.

## Non-Eligible (Courtesy) Riders

Transportation of a non-eligible student is the responsibility of the parent. Non-eligible students may be provided transportation as courtesy riders.

Providing the following conditions exist, courtesy ridership may be granted to a student by the Transportation Department:

- There is a existing bus route; and
- The bus has available space; and
- No additional stops are required.


Bus schedules and routes will not be adjusted for courtesy riders.

Application for courtesy riders are considered by the Transportation Department. The criteria for approving courtesy ride requests will be based on the following:

- Available space;
- Ill health or temporary disability (medical certificate required);
- Age of student priority will be given to K-5 students;
- Safety.

Registered courtesy riders will be carried forward to next school year unless notified otherwise.

Courtesy ridership may be canceled at any time with one week's notice.



## Route 17 - Panda Bus (AM)

The route is intended to transport Ranchero Elem. students from Grandview Bench and South Canoe to Ranchero Elem.

#### **Courtesy Route Extension**

- Route extended to provide service for 13 ineligible Ranchero Elem. catchment students attending Shuswap Middle (SMS).
- Route extended to provide service for 20 ineligible students within walk limits of Shuswap Middle (20<sup>th</sup> Ave & 22<sup>nd</sup> St NE).

## **Effects on Eligible Riders**

- Earlier pick up times for eligible riders attending Ranchero Elem. are 20 min earlier than required.
- Longer ride time for eligible riders attending Ranchero Elem. 10 min.

#### **Bus Transportation Regulation**

- "No additional stops are required".
- "Bus schedules and routes will not be adjusted for courtesy riders".
- "Attend their catchment area school".

#### Improvement to Service if Courtesy Discontinued

- Later pick up time for eligible riders 20 min.
- Shorter ride time for eligible riders 10 min.
- Availability of bus to improve service for other eligible riders.



Past practice has been that the district has not provided courtesy route extensions to middle schools in an effort to support K-8 at rural elementary schools.

It is recommended that the district no longer provide courtesy route extensions for Ranchero Elem. catchment students attending Shuswap Middle or Shuswap Middle students who are within walk limits.



## Route 17 - Panda Bus (PM)

The route is intended to transport Shuswap Middle students to the Gleneden area.

#### **Courtesy Route Extension/Courtesy Stop**

- Route extended to provide service for 15 ineligible Hillcrest Elem. students who are within walk limits (downtown area).
- Route extended to provide service for 2 ineligible Shuswap Middle students who are within walk limits (downtown area).
- Courtesy stop added to provide service for 21 ineligible South Broadview Elem. students who are within walk limits (downtown area).

#### **Effects on Eligible Riders**

• Longer ride times and later pick up time for eligible riders attending Shuswap Middle – 10 min.

#### **Bus Transportation Regulation**

- "No additional stops required".
- "Bus schedules and routes will not be adjusted for courtesy riders".

## **Improvement to Service if Courtesy Discontinued**

- Earlier home arrival time for eligible riders attending Shuswap Middle 10 min.
- Shorter ride time for eligible riders attending Shuswap Middle 10 min.
- Extra seats could provide improved service to eligible Shuswap Middle riders from foothill area who are currently on another route.



- Provide service for 2 Hillcrest Elem. catchment students attending Bastion Elem.; from Shuswap Middle to Bastion Elem.

- Longer ride times for eligible riders attending Shuswap Middle 10 min.
- Earlier pick up time for eligible riders attending Shuswap Middle 10 min.







- The district is currently providing transportation for a student in a wheel chair (this student will be attending high school next year and will ride another bus).

#### **Effects on Eligible Riders**

- Earlier pickup times for eligible riders attending Ranchero Elem. 15 min.
- Early arrival for eligible riders attending Ranchero Elem. requiring additional supervision at school.



- Route extended to provide service for 5 ineligible Ranchero Elem. catchment students attending Hillcrest Elem.
- Route extended to provide service for 5 ineligible Ranchero Elem. students for daycare bus pickup.
- Route extended to provide service for 3 ineligible Hillcrest Elem. catchment students attending Ranchero Elem.
- Route extended to provide service for 2 ineligible Hillcrest Elem. catchment students attending Hillcrest Elem. within the walk limit.
- Route extended to provide service for 4 ineligible Shuswap Middle catchment students attending Ranchero Elem.
- Route extended to provide service for 7 ineligible Grindrod Elem. students (4 attending Shuswap Middle/3 attending Ranchero Elem.).



The route is intended to transport students from North Broadview and Raven to Bastion Elem. and Shuswap Middle.

- Providing courtesy rides for 7 ineligible Bastion Elem. students who are within walk limits.
- Providing courtesy rides for 3 "forced cross-boundary" students attending South Broadview Elem.



## Route 23 - Giraffe Bus (PM)

- Providing courtesy ride for 6 ineligible Bastion Elem. students who are within walk limits at regular stop.

#### **Effects on Eligible Riders**

- Registered ridership well beyond capacity of bus.
- Requires addition of an extra loop (route extension).
- Increased student wait time for eligible riders attending Shuswap Middle 10-15 min.
- Longer ride time for eligible riders attending Bastion Elem. 10-15 min.

#### **Bus Transportation Regulation**

- "The bus has available space".
- "No additional stops required".
- "Bus schedules and routes will not be adjusted for courtesy riders".

#### Improvement to Service if Courtesy Discontinued

- Address bus overcrowding issue and possible overloading.



## Route 28 - Dinosaur Bus (AM)

The route is intended to transport students from Gardom Lake and Mallory Rd. to Ranchero Elem.

### **Courtesy Route Extension/Courtesy Stop/Courtesy Service**

- Providing courtesy rides for 9 ineligible Ranchero Elem. catchment students attending Shuswap Middle.
- Providing courtesy rides for 23 ineligible South Broadview Elem. catchment students within walk limits and from before school care (downtown area).

#### **Effects on Eligible Riders**

- Bus is regularly late to South Broadview Elem. and to Salmon Arm Secondary due to the accommodation of courtesy route extension.
- Complaints about bus arriving late to South Broadview Elem.
- Complaints regarding late arrival for eligible riders attending Salmon Arm Secondary.
- Early arrival of eligible riders attending Ranchero Elem. requiring additional supervision at school 20 min.
- Regular complaints from parents of eligible riders attending Ranchero Elem. regarding early pickup times to accommodate courtesy riders 20 min.

- "Bus schedules and routes will not be adjusted for courtesy riders".
- "Attend their catchment area school".

#### Improvement to Service if Courtesy Discontinued

- Could absorb this route into Route 21, making this bus available to improve service in other areas.



It is recommended that the district no longer support transportation of students to and from private businesses (before and after school care). These care providers should provide their own transportation for their customers.

Past practice has been that the district has not provided courtesy route extensions to middle schools in an effort to support K-8 at rural elementary schools.

It is recommended that the district continue to support K-5 courtesy rides to South Broadview Elem. on another route. The district may be able to discontinue this route and move remaining students to Route 21, making this bus available to improve service on other routes.



# Route 28 - Dinosaur Bus (PM)

The route is intended to transport students from Shuswap Middle to Foothill Rd.

#### **Courtesy Service**

- Providing courtesy rides for 28 ineligible South Broadview Elem. and 9 ineligible Shuswap Middle students to after school care. (Downtown area).
- Providing courtesy rides for students to the LOFT after school care program at the DAC.

#### **Effects on Eligible Riders**

- Longer ride time for eligible riders attending Shuswap Middle 10 min.
- This route could be better used to improve service for riders on other routes or may be able to discontinue route completely.

#### **Bus Transportation Regulation**

- "No additional stops required".
- "Bus schedules and routes will not be adjusted for courtesy riders".

## **Improvement to Service if Courtesy Discontinued**

- Shorter ride time for eligible students attending Shuswap Middle 10 min.
- Provide better service on other routes.



Communication of Board policy and regulations regarding transportation has not been consistent, and access to these documents is currently difficult for students and parents.

The district needs to decide on consistent guidelines and practice around courtesy riders. The Transportation Department needs to be able to make and uphold decisions to ensure that transportation services are fair and equitable for all riders across the district.

## Recommendations

Eligibility criteria for student transportation should be clearly defined and consistently applied to all students in the district.

It is therefore recommended that the Transportation Committee approve the amendments to Regulation 5040.02R with respect to criteria for eligible and non-eligible riders.

There are a number of issues identified on specific routes that relate to accommodation of courtesy riders. The accommodation of courtesy riders is resulting in longer ride times for eligible riders, longer wait times for students at school, earlier pick up times from home, additional resources for early supervision at schools, capacity issues/bus overloads, buses are late dropping students off at school, and numerous complaints from parents and schools.

It is therefore recommended that the Transportation Committee approve the recommendations for the affected routes (as per the above analysis), and that changes are communicated and implemented for the 2018-19 school year.
